RECREATION PROGRAM SCHOLARSHIP APPLICATION

Petoskey Parks and Recreation Department believes every child has the right to participate in recreation programs regardless of financial barriers. In 2017, a scholarship fund was established through local grant dollars and private donations. The fund is dedicated for fee-based recreation programs limited to league play or lessons for youth 17 years old and younger. To maximize the funding available, participants are limited to \$45/year or \$120 per family/year and will be awarded a 25% or 50% subsidy based on income information. Since the scholarship fund is sustained through grants and donations only, limitations may be placed on the amount available.

*Eligibility guidelines are based upon the USDA Food and Nutrition Service - Child Nutrition Program Income

Eligibility Requirements:

- Must be City of Petoskey, Bear Creek or Resort Township Resident – Proof Required (Driver’s License, State of Michigan ID, Property Tax statement, lease agreement with valid ID).
- Must participate in 75% of program (practices, games, lessons). Failure to do so will void any further scholarship consideration.
- Scholarships will not cover any late fees, rentals, reservations, summer day camp, team fees, travel, equipment or other fees determined ineligible by the department.
- Once approved, participants are eligible until December 31 of the current year. A new application will need to be submitted after January 1.
- No additional discounts will be available to scholarship recipients.
- Financial information will need to include **all** household income **before deductions**.
- **All applications will be kept strictly confidential.**
